Budget Approval

Mr. Truschke announced that the Proposed Budget was approved and published on the Bonita District website for a ten day period prior to the public Budget Hearing. The Board must adopt a budget no later than July 15, he said. A copy of the adopted budget must then be electronically submitted to the Superintendent of Public Instruction no later than July 18. The budget would be \$2,667,818.00 and the tax rate would remain at 6.445. Mr. Truschke recommended that the Board approve and adopt the budget for fiscal year 2021-2022.

Board & Administrative Reports

Bayacan

Mr. Kramme asked Mr. Truschke what was going on with Bayacan. Truschke stated that at the last Graham County Board of Supervisors meeting in Safford they approved rezoning site 5 & 6 in favor of Bayacan. Skip Hulett, General Counsel at Nature Sweet, stated that he foresees Bonita and Nature Sweet having a good relationship. Mr. Hulett informed him that they planned on being a support to the school and would still honor the funds promised to the District.

Mr. Truschke said that he and Mrs. Childers had made room for the funds in the donation line in the budget.

The Board expressed their concern for the Research and Development (R&D) facilities on sites 1 & 2, because they won't produce tax if picked up by an educational entity. They estimated it could be a 1/3 percent decrease. There was a question as to who

would enforce the promises from Bayacan. Mr. Truschke said that he would visit Danny Smith, County Supervisor with questions.

Start of School

Mr. Kramme wondered if there would be COVID restrictions for the start of school. Mr. Truschke replied that as of right now there were no restrictions and we are planning on starting with the option to wear a mask, but not mandating it. The mask mandate has been lifted throughout the state and we finished the last school year with the option to wear a mask. Whatever makes the parent and student comfortable. School will start August 9, 2021 with no restrictions.

Forest Fees

Mr. Kramme asked about the forest fee funds when we would receive them and how much it would be. Mr. Truschke said that we have already received it and it's in the budget. Mrs. Childers it came to about \$21,000. The Board agreed that it was better than previous years. Mr. Truschke said that it was a beginning and hoped it would increase.

Inmate Help

Mr. Kramme asked about inmate help for Mr. Brewster. Mr. Brewster said that they have released the crews to work and as of right now he has two inmates and expressed that it was nice to have help again.

Wages

Mr. Truschke expressed his concern about some of our employees not making as much an hour as some students that are working at fast food restaurants. He said he would like to come back to the Board in August with a proposal to at least get the ones below the average up to \$15 an hour.

Adjournment

There being no further business, Mr. Kramme adjourned the meeting at 8:21 a.m.
